Policy on Admissions

The Admission Policy of FISAT lays down the procedure to be followed to admit students in the Institution as per prevailing government rules and regulations to various programmes namely B. Tech, M. Tech, MBA and MCA.

Procedure For Admission To B.Tech Course

The commissioner for Entrance Examination as per the present rules fills up 50% of seats on the basis of rank at engineering entrance examination. This allotment is done course wise and at a place advertised by CEE. The remaining 50% of the seats are filled up by management according to the rules framed by the management from time to time. Management Quota selection is based on weightage given to Marks secured in HSC/Interview/entrance test mark. Merit will be the primary consideration in admission and the students admitted from the merit list. The candidates are required to satisfy themselves in respect of the eligibility before registering the application for admission. No original certificates should be attached and only attested photo copies are submitted. The administration officer ensures the above. For community certificates only certificates issued by the reorganized authorities of the Govt. (as per the guidelines existing from time to time) is accepted. The administrative officer checks and keeps the original certificates at the time of admission. The present minimum eligibility for admission for B.Tech courses are as prescribed by Government of Kerala.

For admission for CEE quota, a common entrance examination is held at various centres

Kerala. The merit list is announced by CEE and counseling for admission is done on the basis of rank obtained at the entrance test. The CEE announces the counseling days through newspapers and other media and on the actual date of counseling, the college and the course are allocated to the student, on the basis of vacancy available at the time of counseling. For management seats advertisement is given for candidates from all categories including NRIs. Along with the application from the prospectus is issued which gives in depth information about course offered, infrastructure facilities, details of laboratories and facilities like library along with details of various scholarships. The details of hostel, playground, industry visits, scholarship Medical Facilities, college rules and regulations are also included. Principal approves the prospectus before bulk printing.

The candidates have to appear for the rank wise allotment on the date and place informed by CEE for securing admission in government quota. Based on the entrance rank, qualifying examination marks and interview, seats are allotted to the eligible students from all categories including N.R.I. 's in management quota seats.

Lapsed seats in government quota will be filled up as per the government rules by CEE, existing from time to time. Lapsed management quota will be filled up from the management quota rank list.

Government quota allotment students will join the colleges as per the instructions from the CEE. For management quota seats, admission letters for provisional admission are sent to the eligible candidates indicating a date and time and the fees to be paid. After verifying the certificates payment of fees is taken. Briefing the students is done on the first day of admission with students and the parents regarding the college's timings, rules and regulations, dress code, Identity card. All Certificates in original are verified and kept with the admission record in the college office.

Procedure for Admission to MBA Course:

Admission to the entire seats of the course will be based on the score of the MAT Test conducted by All India Management Association (AIMA). Other entrance exams which are considered are K MAT, CMAT and CAT. There will be change in the exams considered as per the James Committee recommendations. No seat allotment will be made against management quota or any reservation, either community or caste or financial. The candidates are required to satisfy themselves in respect of the eligibility before registering the application for admission. No original certificates should be attached and only attested photocopies are to be submitted. The administrative officer ensures the above. Candidates primarily should have obtained marks in the qualifying examinations as prescribed below:

MAT Composite Score: 500/ Equivalent for other exams

Degree marks: 50% in aggregate

Candidates are selected on merrohasis from the rank list prepared from the composite score which they had obtained from the environce exam, academic performance, group discussion/task.

Procedure for Admission to MCA Course:

The admission to the MCA course is done purely according to the Government rules and regulations and as prescribed by M.G. University. Management quota selection is based on the weightage given to marks secured in Degree and Entrance test marks based on merit. Graduation in any discipline with Mathematics, Computer Science or Statistics as one of the subjects with not less than 55% of marks, excluding languages in the qualifying examinations. Candidates appearing for Final year degree may also apply

Candidates who have passed the qualifying examination in more than one chance in the subject (excluding languages) will have their percentage marks derated at the rate of 5% of every additional appearance for the purpose of ranking.

Candidates who have passed the qualifying examination in more than three chances in subjects (Excluding languages) are not eligible to apply. Candidates who have passed the qualifying examination in more than one chance in the subject (excluding languages) will have their percentage marks derated at the rate of 5% of every additional appearance for the purpose of ranking.

Candidates who have passed the qualifying examination in more than three chances in subjects (Excluding languages) are not eligible to apply. Candidates whose degree is accepted as equivalent thereto by the APJAKTU are along eligible to apply.

No rounding of marks to the nearest whole number shall be done

Relaxation of 10% marks will be allowed to candidates belonging to the Socially and Educationally Backward Communities referred to in G.O(P)208/66/Edn. and subsequent amendments to the order issued by Government of Kerala from time to time.

There will be no restriction with regard to age for admission.

Must have qualified the Entrance Examination for MCA conducted by the Commissioner of Entrance Examination (CEE), Government of Kerala.

The candidates are required to satisfy themselves in respect of the eligibility before registering the application for admission. The original certificates along with attested photocopies are submitted at the time of admission. The administrative officer ensures the above.

For community certificates only certificates issued by the recognized authorities of the Government (Changed from time to time) is accepted. The administrative officer checks and keeps the original certificates at the time of admission. The present eligibility for admission for MCA course is as prescribed by APJAKTU.

Candidates should have obtained marks as prescribed below.

For admission to the MCA course, advertisement is given for candidates from all categories. Along with the application form, the prospectus is issued which gives in depth information about matters like, the course offered, infrastructure facilities, details of laboratories and facilities like library, hostel playground, internet and other communication systems, gymnasium, mess, transport, industrial visits, Scholarships, medical facilities, college rules and regulations. Principal approves the prospectus before bulk printing.

The list of eligible students are prepared based on the criteria specified before, and admission letters for provisional admission are sent to the candidates indicating a date and time and the fees to be paid. After verifying the certificates, payment of fees is taken.

Briefing the students is done on the first day of admission with students and parents regarding the college's timing rules and regulations, dress code, identity card.

All certificates in original are verified and kept with the admission records in the college office.

Procedure For Admission For M.Tech Course

For admission to the M.Tech course, advertisement is given for candidates form all categories, along with the application for, the prospectus is issued which gives in depth information about matters like, the course offered, infrastructure facilities, details of laboratories and facilities like library, hostel playground, internet and other communication systems, gymnasium, mess, transport, industrial visits, Scholarships, medical facilities, college rules and regulations. Principal approves the prospectus before bulk printing. The eligibility for admission will be subjected to the rules and regulation of APJAKTU and AICTE. For admission to M.Tech degree course the candidates should have

i) Valid GATE Score

ii) For M.Tech in CSIS : Atleast 60% marks in BE/B. Tech in CSE/IT or MCA

iii) For M.Tech in CE : Atleast 60% marks in BE/B. Tech in ECE

iv) Non-GATE candidates, as a pass in the above-mentioned degree is sufficient.

v)For SC/ST candidates, a pass in the above-mentioned degree is sufficient.

vi) Candidates who have degrees awarded from universities other than APJAKTU. shall submit an Eligibility Certificate from APJAKTU as well as a Migration Certificate at the time of admission.

vii) Merit List for the different courses/categories will be published in the website/college notice board based on merit.

viii) Selected candidates shall take admission at the appointed time after paying the tuition fees and other university fees.

ix) selected candidates are reduced to deposit their original certificates at the College Office at the time of admission.
