## CAMPUS RULES - GENERAL DISCIPLINE CONDUCT AND BEHAVIOUR

- All students must strictly comply with directions from college staff regarding academic matters and general discipline. Students are expected to uphold mutual respect in all interactions and refrain from engaging in conflicts or disputes.
- As a matter of general discipline, students are expected to uphold the dignity and decorum of the
  institution and cooperate in maintaining cleanliness throughout the college buildings and campus. This
  responsibility is shared collectively among all students.
- 3. Every student should wear the prescribed uniform at all times on campus.
  - a. Boys Slack shirt pants with shirt lucked in and belt 2.5cm wide, black colour black shoes with dark blue socks
  - b. Girls- Slack shirt-pants-jacket-black shoes with dark blue socks
  - c. Workshop Coat Dark grey
  - d. Separate uniforms are specified for MBA, MCA & Integrated MCA students. No alterations are allowed.
  - e. Jeans and T-shirts are not allowed.
- 4. While on campus, all students must be in possession of the identity card issued by the college and must prominently display it.
- 5. Usage of Mobile Phones is strictly prohibited inside Classrooms/Labs/Workshops.
- 6. Students must strictly adhere to college timings. Late entry to classrooms, labs, or workshops will not be permitted. Students arriving late may enter classes only with the permission of the teacher.
- 7. Smoking/Consumption of Alcohol/Narcotic substances are strictly prohibited within the campus. Students are advised to desist from all these habits as it is injurious to health.
- 8. Students should get prior written permission from the Principal to organise any function or to collect funds for any purpose. Also, no student shall represent any club or association without getting permission from the Principal.
- 9. Students should refrain from participation in any political party activities or communal politics inside the campus.
- 10. Leave of absence will be granted only on medical grounds. Such leave will be considered only for the purpose of granting condonation of shortage of attendance. Leave application should be submitted to the Principal /HOD through the group advisor before availing the leave.
- 11. Duty leave will be granted only for the work/ activity directly connected with the college and the students should take prior sanction for the same. University rules will be strictly followed for duty leave and condonation of attendance.
- 12. Students must use social media responsibly. Misuse that harms FISAT's interests will be considered a serious violation of conduct.
- 13. Students bringing any vehicle to the college should submit a copy of the registration certificate and driving licence and get permission from the Administrative Officer.
- 14. Ragging is strictly prohibited and is a punishable offence. (Undertaking in this regard, signed by both, parent and student should be submitted separately)
