

- All the posts are Executive Posts.
- Posts having S.NO 1,2,3,4,5 are office bearer posts.
- Parliamentary mode of election refers to a decentralized system of election in which students of each class in an institution choose their representatives through the mode of secret ballot, who in turn elect the Executive Members of the Union from among themselves through the mode of secret ballot.
- The Executive/ office bearer Posts mentioned in S. Nos. 1, 2, 3, 4, 5, and 6 will be elected by and from all the elected class representatives of the College. However, the election to the post of Vice-Chairperson (S.No.2) shall be elected from women students by all the elected class representatives of the College.
- The Post mentioned in the S.NO. 7 WOMEN REPRESENTATIVE will be elected by and from among the women students from the elected class representatives of the College.
- The Posts mentioned in the S.No 8 to 13 will be elected by and from among UG (B Tech) students of respective Branch and the Posts mentioned in the S.No 14 to 21 will be elected by and from among PG (M.Tech/MBA/MCA/IMCA) students representatives elected from the corresponding course.

Only those full-time regular students whose names are on the Final Electoral Roll are eligible to take part in the student representative election. Requests, if any, for making correction, alteration or deletion in the Electoral Roll shall be submitted in writing to the Returning Officer within the time limit fixed.

Every elector shall be at liberty to nominate (propose) a qualified student to fill up a vacancy. No elector can nominate (propose) more than one candidate for one post. The eligibility criteria prescribed by the Honourable Supreme Court of India shall strictly be followed. Every nomination shall be in the prescribed form and shall be made by an elector in writing, and shall be seconded by another elector.

No elector can second more than one candidate for one post. Every such nomination shall be accompanied by the consent of the nominee agreeing to serve on the class representative, if elected.



The candidate shall furnish the required declarations on the Nomination Paper and then obtain the verification report from the concerned faculty advisor and Head of the Department on the Nomination Paper.

The Nomination paper shall be put in sealed covers inscribing the name of the post and must be submitted to Returning Officer, by the candidate him/her self in person or by his/her authorised representative who shall be one included in the electoral roll with identity proof, in his office alone on or before the time limit.

Proforma of the Nomination Paper is available in the Office of the Returning Officer or can be taken from official College Website. A candidate shall have one opportunity to contest for the post of office bearer, and two opportunities to contest for the post of an executive member.

Any candidate may withdraw his/her candidature by notice in writing/printed signed by him/her and delivered in person to the Returning Officer on or before the time limit.


Withdrawal once made shall be final. Proforma of the withdrawal of candidature form is available in the Office of the Returning Officer or can be taken from official College Website. The candidates or their agents, if any, appointed in writing and approved by the Returning Officer alone shall be permitted to be present on the occasions of scrutiny of nominations, polling and counting of votes.

Eligibility criteria for Candidate

1. Should be a fulltime regular student of the course
2. Have no academic arrears as on the of publication of notification date
3. Have attained 75% for male ,73% for female, 70% for pwd of attendance in the previous semester
4. Have not been subjected to disciplinary proceedings by the College / University

The Honourable Supreme Court of India have perused the Report of the Committee, headed by Mr. J. M. Lyngdoh, former Chief Election Commissioner, constituted by the Ministry of Human Resource Development, Government of India for making recommendations and suggestions relating to the Students' Union Elections in terms of the order of the Supreme Court dated 12.12.2005. The Supreme Court have accepted the recommendations as an interim measure and directed to implement the recommendations subject to such modifications indicated therein. The recommendations have been incorporated as a part of the order. The Supreme Court have also made it clear that the recommendations made, which the court have accepted to be adopted as an interim measure, shall be followed in all College/University Elections, to be held hereinafter, until further orders. The full text of the verdict of the Supreme Court forms part of this election notification. All the recommendations



made by the committee and accepted by the Supreme Court are applicable to this election. The directives of the Supreme Court shall be supplementary to the clauses contained in the Constitution for College Unions and the rules for the conduct of elections to College Unions contained therein and the same shall supersede any of the clauses that are inconsistent with it.
